

• It's ok for someone, myself included to say something that disturbs you, we are not passing moral judgements on each other.


• Protect one another- keep what was said here.



## **Ethics in a Global Society**

- Postmodernism offered an epistemological skepticism about enlightened modernism and its belief in universally accepted truths to be discovered and imparted for the improvement of people's lives at an individual level.
- Metamodernism & beyond
  - Ontology of metamodernism is metaxis.
  - Aligned with the epistemology of modernism and postmodernism, metamodernism is based on 'as if' thinking rooted in Immanuel Kant's 'negative' idealism (Vermeulen and Van den Akker 2010). Though meta-modernists can subscribe to the search for usable knowledge and truth, as well as the need for reason, they do not ground their epistemology on the subject—object metaphysics of modernism. Instead, they stress the constant situatedness of individuals in a communal or cultural context that limits our understanding of the world (Feldman 2005).

Ontology is the philosophical study of being. As one of the most fundamental concepts, being encompasses all of reality and every entity within it. Metaxis- Between Modern and Post modern, sometimes like a swinging pendulum.

Epistemology (as if)- the theory of knowledge, especially with regard to its methods, validity, and scope, and the distinction between justified belief and opinion.
